

## TERMS & CONDITIONS

These Terms & Conditions apply to all bookings with **Shore Thing Charters** ("Shore Thing", "we", "our", "us"). By confirming your booking and/or boarding the vessel, you / your client ("the Primary") and your guests agree to the following:

### 1. Charter Capacity & Access

1. The maximum number of guests is specified on your booking confirmation. Requests for additional guests must be made in writing at least 48 hours prior to your charter and are subject to approval.
2. No additional guests will be permitted to board on the day of charter. Refunds will not be given for no-shows or late arrivals.
3. Boarding is only permitted at the confirmed charter start time unless prior written approval for early access is provided by Shore Thing.
4. Guests must vacate the vessel by the agreed finish time. Extensions must be approved by the Master and will incur an additional hourly charge.
5. Access to lower deck areas and cabins is by approval only. Shore Thing reserves the right to restrict access to protect the vessel and crew.

### 2. Guest Conduct & Safety

1. The Primary is responsible for the behaviour, safety, and conduct of all guests and contractors onboard.
2. All guests must comply with crew instructions at all times.
3. Nudity, strippers, topless waitstaff, or lewd entertainment are strictly prohibited.
4. The possession, sale, or use of illegal substances is strictly forbidden. Guests found in breach will be removed, and police may be notified.
5. Crew reserve the right to remove any guest behaving in a dangerous, disruptive, or offensive manner.
6. The Master may terminate the charter immediately if safety is compromised – no refunds will apply.

### 3. Responsible Service of Alcohol

1. RSA regulations apply onboard. Crew may refuse service to anyone underage or intoxicated.
2. To ensure safety while docking, the bar will close 30 minutes before disembarkation.

**4. Footwear & Attire**

1. Shore Thing enforces a **no-shoe policy**. Shoes will be safely stored onboard during your charter.
2. Guests should wear appropriate and safe attire for a marine environment.

**5. Facilities**

1. Designated guest bathroom will be identified during the safety briefing.
2. Showers are not available for guest use; there is a freshwater shower located on the exterior for any guest wishing to rinse off after swimming.
3. Do not flush any sanitary items or non-biodegradable waste. Costs to repair blockages will be deducted from your security deposit.

**6. Catering & Food**

1. Food is to be consumed only in main guest areas, not in lower cabins.
2. Shore Thing will take reasonable steps to accommodate dietary needs, but we cannot guarantee allergen-free meals. All dietary requests must be confirmed in advance.

**7. Music & Entertainment**

1. The yacht's sound system is available for guest use. Volume and operation are at the discretion of the crew.
2. If you wish to supply your own playlist, please provide a public Spotify playlist in advance.
3. Any additional sound equipment or DJs must be approved prior to the charter.

**8. Smoking & Vaping**

Smoking and vaping are permitted only in designated exterior areas, and only while the yacht is at anchor.

**9. Swimming & Water Activities**

1. All in-water activities must be confirmed at booking. Deckhands are required for group swimming at the Primary's expense.

2. No alcohol is to be consumed prior to swimming.
3. A maximum of 20 guests are permitted in the water at one time. Guests must provide their own towels.

#### **10. Water Taxis & Transfers**

All water taxi movements must be arranged by the Primary and approved by the Master. Any associated costs are the Primary's responsibility.

#### **11. Media & Promotion**

Shore Thing Charters may use photos or media from events for promotional purposes on our website or social channels. Please inform us in writing prior to your charter if you do not wish media to be shared.

#### **12. Payment & Cancellations**

1. A **50% deposit** is required within 72 hours of booking to confirm your charter.
2. Remaining balance and security deposit are due **7 days prior** to the charter date.
3. A **\$2,000 refundable security deposit** is payable prior to boarding. This may also be secured with preferred Broker.
4. Cancellation 30–10 days prior: deposit non-refundable.
5. Cancellation less than 10 days prior: full payment is due, non-refundable.
6. Cancellations must be made in writing.
7. Shore Thing reserves the right to cancel due to weather, safety, or unforeseen circumstances. In such cases, an alternate date or refund will be offered.

#### **13. Additional Charges**

Any additional costs (e.g. time extensions, extra guests, water taxis, extra beverages, or damages) will be deducted from the security deposit. If costs exceed the security deposit, an invoice will be issued and must be settled within 7 days.

#### **14. Damage & Liability**

1. The Primary is responsible for any damage, loss, or injury caused by themselves, their guests, or contractors.
2. Any damage must be reported to crew immediately.
3. Repair mend costs exceeding the security deposit amount must be paid within 7 days.
4. The Primary indemnifies Shore Thing, its owners, crew, and agents from all claims, losses, or damages arising from the Primary's actions, negligence, or failure to comply with these terms.

**15. Acknowledgement of Risk & Waiver**

By boarding the vessel, all guests acknowledge that boating and water-based activities involve inherent risks, including but not limited to injury, seasickness, and changing weather conditions.

Guests participate entirely at their own risk and release Shore Thing Charters, its employees, and affiliates from any liability for loss, injury, or death resulting from participation, except where prohibited by law.

**16. Master's Authority**

The Master is responsible for the safety and operation of the vessel. Guests must comply with the Master's instructions at all times. The Master may refuse access, alter itineraries, or terminate a charter if guest behaviour or conditions compromise safety.

**17. Governing Law**

These terms and conditions are governed by the laws of Australia.

**18. Acceptance**

By making payment or boarding the vessel, the Primary acknowledges they have read, understood, and agree to these terms and conditions. Shore Thing would like to thank you in advance for respecting our terms and conditions and look forward to welcoming you on board.
